2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of the male Krukenberg tumor. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: In this manuscript, authors reported a rare case of spermatic cord metastasis of poorly differentiated gastric adenocarcinoma with signet ring cell component that was identified by inguinal mass and ipsilateral hydronephrosis. be educational. However, there are some issues that should be addressed. Hydronephrosis should be presented in more detail. Authors should provide CT images showing the origin of left ureteral stenosis and explain the potential causes of hydronephrosis based on the CT findings. In the section of Treatment or Outcome and follow-up, authors should describe how many courses of the palliative chemotherapy regimen were completed. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 10 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Formosa Medical Editors on was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
