2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a case report of simultaneous bilateral acromial base fractures after staged reverse total shoulder arthroplasty. The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The case of simultaneous bilateral acromial base fractures is interesting. However, there are some minor problems that need to be addressed in this study. 1. In the results section, the patient's preoperative and postoperative clinical data</p>	[Y]

should be fully updated. 2. The classification of fractures needs to be clarified. 3. The evaluation of the preoperative shoulder function needs to be provided. 4. In Figure 3, it will better if the authors provided CT scan at 2 years after plate fixation for readers. The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 10 references are cited, including 5 references published in the last 3 years. There are 1 self-citation. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by REVIETEX was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the Signed Informed Consent Form(s). In addition, the authors are required to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
