(1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors found that the bowel cleanser 32-tablet sodium phosphate (Quiklean®) is an adequate bowel cleansing preparation with better tolerability and acceptability as compared with the standard comparator 2-L polyethylene glycol (PEG)/bisacodyl (Klean-Prep/Dulcolax®); and (3) Format: There are 7 tables and 1 figure. A total of 29 references are cited, including 4 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and Written Informed Consent. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text; and (3) Please don’t include any *, #, †, §, ‡, ¥, @....in
