The topic is within the scope of the WJCC. (1) Classification: Grade B, Grade B and Grade C; (2) Summary of the Peer-Review Report: This is an interesting and meaningful study, this study is less common. However, there are some issues in the manuscript that need to be added, for example, What is the difference between the treatment of</p>	[Y]

intracortical chondroma and osteoid osteoma? What is the guiding significance of the imaging diagnosis of this tumor for clinical treatment? etc. The questions raised by the reviewers should be answered; and (3) Format: There are 1 table and 6 figures. A total of 10 references are cited, no reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade A and Grade B. A language editing certificate was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Recommendation: Conditionally accepted.
