The topic is within the scope of the WJG. (1) Classification: Grade C; (2)</p> <p>Summary of the Peer-Review Report: This study reports endoscopic retrograde cholangiopancreatography as a new treatment strategy for removal of gallstones. The study is interesting; however, there</p>	[Y]

are several problems with the manuscript. A key point of this strategy is successful cannulation into the gallbladder. Cystic duct direction (proximal/distal, right/left, or cranial/caudal) and length both affects the success of cannulation into the gallbladder. The author should discuss these issues. The cystic duct dilation process should be described in detail. The location of gallstones should be shown in detail. The questions raised by the reviewers should be answered; and (3) Format: There are 5 tables and 3 figures. A total of 27 references are cited, including 2 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the CARE Checklist-2016 with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Hospital Research Fund (general project) from The Second Affiliated Hospital of Army Medical University. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text.
