A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors need to provide the CARE Checklist-2016, and surgical treatment informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited/invited manuscript. The study was supported by the Anhui Province Key Clinical Specialist Construction Fund; and Anhui Province Central Guided Local Science and Technology Development Funding Project. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for
