Fistula and intraabdominal fistula are common complications of Crohn's disease(CD), but complex rectal fistula with abscess formation is rare. Tumor necrosis factor antagonists combined with percutaneous drainage or surgical intervention is optimal treatment for fistulizing CD with intraabdominal abscess. There is no study show the efficacy of vedolizumab in such complicated condition.

Crohn's Disease

Medical Condition

A chronic inflammation of the digestive tract.

- Rare (Fewer than 200,000 cases per year in US)
- Requires lab test or imaging
- Treatments can help manage condition, no known cure
- Can be lifelong

The exact cause is unknown but heredity and malfunctioning immune system play a role. Common symptoms include abdominal pain, diarrhea, malnutrition and fatigue. Anti-inflammatory drugs and immune system suppressors help in long term remission.

Symptoms

Symptoms range from mild to severe and include:

- Abdominal pain and tenderness
- Feeling of a filled abdomen
- Tiredness
- Diarrhea, which can be mixed with blood, mucus or pus in severe cases
- Constipation
- Nausea
- Weight loss
- Fever
- Rectal bleeding
- Inflammation of the joints, eyes, and mouth

Children with crohn's disease may report retarded growth or delayed sexual development.
