The topic is within the scope of the WJG. However, the scientific quality doesn't meet the requirement of WJG. (1) Classification: Grade D and Grade D; (2) Summary of the</p>	[Y]

Peer-Review Report: The authors tried evaluate the anti-NAFLD effect of papaya in high fat diet induced obesity in rats, and concluded that papaya can suppress the lipogenic pathway, improve the balance of antioxidant status and lower systemic inflammation. The study is well designed. It is a good study showing the beneficial effects of papaya. However, the authors need to review the literature and discuss any health benefits in general population and individuals with obese and other health issues. Some repeated sentences from the method section should be deleted and revised. The questions raised by the reviewer should be answered; and (3) Format: There are 2 tables and 5 figures. A total of 34 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Animal Care and Use Committee Approval Form or Document, and The ARRIVE Guidelines. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by The National Research Council of Thailand, and The Thailand Reseach Fund. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the
