olaparib. The topic is within the scope of the WJGO. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This MCAC case treated with olaparib is very rare and this report is very informative for readers. First, histological evidences presenting MCAC are needed. Second, more follow-up period will improve the quality of the case presentation. The questions raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 27 references are cited, including 6 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided informed consent and CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJGO. The corresponding author has published 1 article in the BPG. 5 Issues raised: I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
