The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The case report could be educational, even though it adds nothing new to the existing medical literature. Vancomycin induced seizure was first described by Caglayan et al in a 10-year-old girl in 1992. The case</p>	[Y]

report section is unnecessarily long and should be shortened. The authors should provide information about the staging, especially to rule out brain metastasis. The authors should also provide necessary information/data as suggested; and (3) Format: There are 3 figures. A total of 36 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and the written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China and Key Innovative Team of Shanghai-Top-Level University Capacity Building on Clinical Pharmacy and Regulatory Science at Shanghai Medical School of Fudan University. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can

	<p>be reprocessed by the editor; (4) I found the “Case Presentation” did not meet our requirements.
