2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes an observational study of the saliva microbiota for cancer detection. The topic is within the scope of the WJG. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: Overall it is a sound study with impressive microbiome analysis for potential application of early detection of pancreatic cancer. However, there are still some pointes need to be further improved. From the</p>	[Y]

innovation of the study, the research team also compared the microbiota profiles difference between the patients with different symptoms and without symptoms, which may help in early detection of pancreatic cancer. The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 2 figures. A total of 42 references are cited, including 16 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, and written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and fill out the STROBE checklist with page numbers. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by expert funding of National Natural Science Foundation of China; the 13-5 project for disciplines of excellence-Clinical Research Incubation and Innovation Project, West China Hospital, Sichuan University; Clinical Research Incubation and Innovation Project of West China Hospital; and Science and technology project of Sichuan Province. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant
