(1) Classification: Grade B and Grade D; (2) Summary of the Peer-Review Report: In this review, the authors aimed to summarize current knowledge about the role of O-GlcNAcylation in the process of colorectal carcinogenesis. manuscript is brief and comprehensive regarding the cellular/immunological functions of O-GlcNAcylation in CRC. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 1 figure. A total of 100 references are cited, including 32 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Two Grades B. A language editing certificate issued by LetPub was provided. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGS. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The second author's name (Fang-Xing Peng), email, and ORCID are not added to the system, please add them. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
