(1) Classification: Grade B, Grade C and Grade B; (2) Summary of the Peer-Review Report: The study has important guiding significance for the radiofrequency ablation of clinical liver lesions. This is a well-written, good structured recommendation for effect of RFA on the regional liver. The term "Bama Miniature Pigs" should be added</p>	[Y]

to the title of the manuscript. This study was well conducted with good methodology and intelligible English. The references need to be updated; and (3) Format: There are 3 tables and 6 figures. A total of 13 references are cited, no including references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B, Grade B and Grade B. A language editing certificate issued by Aiyiping Group was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Animal Care and Use Committee Approval Form, and The ARRIVE Guidelines. The authors need to provide the Institutional Review Board Approval Form, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Fund Sponsorship of the Capital Public Health Project. The topic has not previously been published in the WJGO. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the
