| 2 | <p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a prospective study of the effect of suspension training on the neuromuscular function, postural control and knee kinematics of patients after anterior cruciate ligament reconstruction. The topic is within the scope of the WJCC. (1) Classification: Grade C and Grade D; (2) Summary of the Peer-Review Report: This is an interesting</p> | [Y] |

study, and the manuscript is well written. However, the differential data presented in both Figure 4 and Table 3 should be more specifically explained. Moreover, the authors are suggested to include further discussion in the conclusion paragraph on the future direction and possible application of the results. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 43 references are cited, including 13 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade B and Grade A. A language editing certificate issued by Springer Nature Author Services was provided. 3 Academic norms and rules: The authors provided the Institutional Review Board Approval Form, the Clinical Trial Registration Statement, the written informed consent, the CONSORT 2010 Statement, and the Biostatistics Review Certificate. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors mentioned funding in the author contributions section. Please confirm if the study was financially supported. If yes, please upload the approved grant application form(s) or funding agency copy of any approval document(s). If no, please delete relevant information

from the manuscript; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) I found the authors did not write the "article highlight" section. Please write the "article highlights" section at the end of the main text; (5) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces; (6) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; Please use superscript numbers for illustration; and for statistical significance, please use superscript letters. Statistical significance is expressed as aP < 0.05, bP < 0.01 (P > 0.05 usually does not need to be denoted).
