high medical need. The treatment of the patient is very interesting for the field,. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 4 figures. A total of 23 references are cited, including 12 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
