The topic is within the scope of the WJR. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: the paper has substantial content with relatively broad citation, and is an important review of information in clinical features, course and outcome of COVID-19, however, the role of CT is controversial in this paper. also it can Introduce some specific CT follow-up guidelines, such as CT scan interval, different groups of treatment; and (3) Format: There are 4 tables and 3 figures. A total of 71 references are cited, including 69 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the references in Arabic numerals according to the citation order in the text. The reference numbers will be superscripted in square brackets at the end of the sentence with the citation content or after the cited author's name, with no spaces. 6 Re-Review: Not required. 7 Recommendation: Conditionally
