interesting and well written. However, there are some issues should be addressed; and (3) Format: There is 1 table and 7 figures. A total of 42 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form, Institutional Animal Care and Use Committee Approval Form, and The ARRIVE Guidelines. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 7%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by the National Natural Science Foundation of China; the National Clinical Key Subject of China; and the Technology Plan Program of Sichuan Province. The topic has not previously been published in the WJG. The corresponding author has published 2 articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any

Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (5) I found the authors did not write the “article highlight” section. Please write the “article highlights” section at the end of the main text. 6 Re-Review: Not required. 7 Recommendation: Conditionally accepted.</p> <p><b>Editorial Office Director:</b> I have checked and revised the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report, the full text of the manuscript, and the relevant ethics documents, all of which have met the basic publishing requirements of the World Journal of Gastroenterology, and the manuscript is conditionally accepted.
