2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor:</b> 1 Scientific quality: The manuscript describes a review of the exploration of sex-specific and age-dependent COVID-19 fatality rate and treatment strategy. The topic is within the scope of the WJR. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The current outbreak of the global storm of coronavirus disease 2019 (COVID-19) caused by severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2). the healthcare systems in all countries around the world faced incredible challenges with COVID-19 since its discovery. This study was proposed to explore the sex-specific and age-dependent COVID-19 fatality rate and treatment strategy. The present review is an interesting manuscript. However, some references should be added in this manuscript. The questions raised by the reviewer should be answered; and (3) Format: There are 5 figures. A total of 99 references are cited, including 75 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. However, the highest single-source similarity index showed to be 11%, the total similarity index showed to be 53% in the CrossCheck report. According to the BPG's policy, the single-source similarity index should be less than 11%, and the total similarity index should be less than 30%. The authors need to rephrase the repeated parts. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) PMID and DOI numbers are

	<p>missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.</p> <p><b>Editorial Office Director:</b> I have checked the comments written by the science editor.</p> <p><b>Company Editor-in-Chief:</b> I have reviewed the Peer-Review Report and the full text of the manuscript, all of which have met the basic publishing requirements, and the manuscript is conditionally accepted with major revisions.
