However, minor changes are needed. The questions raised by the reviewer should be answered; and (3) Format: There is 1 table and 1 figure. A total of 26</p>	[Y]

references are cited, including 26 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors need to provide the CARE Checklist-2016 with page number, the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the Institutional Review Board Approval Form. The authors provided written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 4 grants. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Case Presentation" section was not written according to the Guidelines for Manuscript Preparation.
