2	<p><i>Editorial Office's Comments</i></p> <p>Science Editor: 1 Scientific quality: The manuscript describes a basic study of the influence of anastomoses on intestine ischemia and cefuroxime concentrations. The topic is within the scope of the WJG.</p> <p>(1) Classification: Grade C; (2) Summary of the Peer-Review Report:</p>	[Y]

The authors found that an intestinal anastomosis creates ischemic microenvironment, thus increases lactate and glycerol, decreases glucose. The measurement of cefuroxime levels has added some novelty. The results should be presented better though. Table 1 should be showing anastomosis and non-anastomosis levels of the ischemic metabolites; and (3) Format: There are 3 tables and 3 figures. A total of 32 references are cited, including 14 references published in the last 3 years. There are 10 self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, Institutional Animal Care and Use Committee Approval Form, the Institutional Review Board Approval Form, and The ARRIVE Guidelines. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Orthopaedic Research in Aarhus Foundation. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure
