reference list and list all authors of the references. Please revise

written according to the Guidelines for Manuscript Preparation.
Please re-write the "Case Presentation" section, and add the
"FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND
FOLLOW-UP" sections to the main text, according to the Guidelines
and Requirements for Manuscript Revision. 6 Re-Review: Not
