The topic is within the scope of the WJD. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This paper is usefully reviewed the methodology to glycaemic index variability. However, some questions raised by the reviewer should be answered; and (3) Format: There are 6 tables and 1 figure. A total of 126 references are</p>	[Y]

cited, including 14 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJD. 5 Issues raised: (1) The reference's number should be put in the square bracket; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout. 6 Re-Review: Not required. 7 Recommendation: Conditional acceptance.
