sub-epithelial lesion which resulted to be a GIST. This approach is novel since only reports have been published so far. The manuscript is well written. Some lines of information are missing and may improve the manuscript. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 6 figures. A total of 12 references are cited, including 3 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade B and Grade B. A language editing certificate issued by MedE was provided. 3 Academic norms and rules: The authors provided the CARE Checklist-2016, and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Nature Science Foundation of China; and the Sichuan Science and Technology Planning Project. The topic has not previously been published in the WJG. The corresponding author has published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
