The topic is within the scope of the WJGO. (1) Classification: Grade C and Grade B; (2) Summary of the Peer-Review Report: The paper is interesting, but there are some issues that need further clarification. There are still some problems in the core prompts and conclusion that need to be explained and</p>	[Y]

adjusted. There are also slight English grammatical errors in the manuscript that need to be corrected. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 2 figures. A total of 30 references are cited, including 2 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. The authors need to fill out the STROBE checklist with page numbers. No academic misconduct was found in the Bing search. The highest single-source similarity index in the CrossCheck report showed to be 8%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4
