diagnostic. The paper discussed mainly the role of artificial intelligence-assisted endocytoscopy in colorectal polyps, colorectal cancer and IBD. It means that EC has shown an excellent diagnostic accuracy, offering to aid in the in-vivo diagnosis of lesions in the lower GI tract. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 1 figures A total of 34 references are cited, including 12 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Three Grades B. No language editing certificate was provided. 3 Academic norms and rules: No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the AIGE. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
