Reviewer Comments: (1 Scientific quality: The manuscript describes a case report of the recurrent perimesencephalic nonaneurysmal subarachnoid hemorrhage. The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: It is an interesting manuscript. Authors succeed to present their data in a clear way adding information to the existing literature; and (3) Format: There is 1 table and 5 figures. A total of 24 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the CARE Checklist–2016 and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, and add "FINAL DIAGNOSIS", "TREATMENT", and "OUTCOME AND FOLLOW-UP" section to the main text, according to the Guidelines and Requirements for Manuscript Revision. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.

Reviewer #1: Format: There is 1 table and 5 figures. A total of 24 references are cited, without references published in the last 3 years. The authors need to update the references. There are no self-citations.

Response: We researched the references related to this disease in the past 3 years, and added two references within 3 years. In REFERENCES, it is the 18th and 19th articles. We were pleasantly surprised to find that the World J Clin Cases magazine in 2019 An article: "Lin XQ, Zheng LR. Response: We have rewritten the "case introduction" section in accordance with the magazine's manuscript revision guidelines and requirements, and have considered the language. Therefore, the characteristic of the case is a disease that hardly recurs within a period of time, and recurs within a few days. In "Treatment", we described in detail the specific process of two bleeding during the patient's hospitalization.
