The topic is within the scope of the WJCO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: This review summarizes the status quo on the adverse effects of the immunotherapeutic agents currently</p>	[Y]

employed in cancer therapy. The topic covers an array of the affected systems (cardiovascular, dermatologic, endocrine, gastrointestinal, neurologic and pulmonary systems) and describes the known adverse effects caused by use of the specific agents. The reviewer finds this paper intriguing in that it is written for those who work in the clinic. It may help physicians to treat cancer patients properly with the immunotherapeutic agents and when they encounter the problems pertinent to the agents, they could find out the remedy. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table. A total of 53 references are cited, including 27 references published in the last 3 years. There is 1 self-citation. 2 Language evaluation: Classification: Grade A and Grade B. The authors are native English speakers. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCO. 5 Issues raised: No additional comments. 6 Recommendation: Conditional acceptance.
