The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors put forward a concise and thorough regarding the yield of surgery in solid pseudopapillary</p>	[Y]

neoplasms of the pancreas: a case series and literature review. The cases are well presented, the statistical analysis adequate and the follow up period is 4.7 years. The questions raised by the reviewers should be answered; and (3) Format: There are 6 tables and 2 figures. A total of 31 references are cited, including 9 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Two Grades A. A language editing certificate issued by Enago was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (4) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. 6 Recommendation: Conditional acceptance.
