Peer-Review Report: This study is interesting, however some points deserve further details of clinical relevance. The conclusion that follow-up of CD patients is not optimal without any analysis of contributing factors is quite simple. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 1 figure. A total of 15 references are cited, including 3 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade A and Grade B. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the STROBE checklist, and the Institutional Review Board Approval Form. Written informed consent was waived. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Takeda Pharmaceuticals. The topic has not previously been published in the WJG. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (4) I found the authors did not write the "article highlight"
