(1) Classification: Grade B, Grade C and Grade C; (2) Summary of the Peer-Review Report: The study is among the very few researches that addressed the correlation of BG with clinical, endoscopic and histological activity, as well as with some serological biomarkers and fecal calprotectin. The manuscript is original and represents a novelty. However, some points should be addressed by the authors. The questions raised by the reviewers should be answered; and (3) Format: There are 3 tables and 4 figures. A total of 69 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A, Grade A and Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the STROBE Statement, and the Institutional Review Board Approval Form. Written informed consent was waived. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 3 grants. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that
