The topic is within the scope of the WJGS. (1) Classification: Grade C and Grade B; (2) Summary of the Peer-Review Report: The reported confidence intervals are satisfactorily narrow. However, some of the material</p>	[Y]

and methods sections need to be revised and interpreted. Authors should describe the type of surgery for the patients. The questions raised by the reviewers should be answered; and (3) Format: There are 7 tables and 3 figures. A total of 60 references are cited, including 11 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form and Written informed consent. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China; Innovation Fund for Medical Sciences of Chinese Academy of Medical Sciences. The topic has not previously been published in the WJGS. The corresponding author has not published 1 article in the BPG. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) I found the authors did not
