the other tumors in discussion. mention of mitotic count should be done per 50 HPF, it should be less than 1/50 but in discussion mentioned mitosis was rare which should be specific. Language editing should be carried out through-out the manuscript; and (3) Format: There are 2 tables and 4 figures. A total of 23 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Signed Informed Consent, and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Key Projects of Natural Science Research in Colleges and University of Anhui Province. The topic has not previously been published in the WJBC.
