Diabetes should also be considered as a common associated factor for the disease; and (3) Format: There are 2 figures. A total of 18 references are cited, including 5 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. co-author was provided. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent where the patient signed to agree to the treatment, and the CARE Checklist-2016 filled with page number (the provided one was not the 2016 version). The highest single-source similarity index in the CrossCheck report showed to be 5%. According to our policy, the overall similarity index should be less than 30%, and the single-source similarity should be less than 5%. Please rephrase these repeated sentences. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Author contribution" section. Please provide the author contributions; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) please don't include any *, #, †, §, ‡, ¥, @....in your manuscript; (4) please provide an audio core tip file where the core tip content is recorded; and (5) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, the written informed consent where the patient signed to agree to the treatment, and the CARE Checklist-2016 filled with page number. 6 Re-Review: Not required. 7 Recommendation: Conditionally
