The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This study is an interesting subject and a well-organized manuscript. However, the discussion in this case is poor. The</p>	[Y]

authors should mention that the proliferative glomerulonephritis with monoclonal IgG deposits is reversible or irreversible in this case. In which basis the end points for outcomes and follow up in this case were selected? The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 6 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Signed Informed Consent. The authors need to fill out the CARE Checklist – 2016 with page numbers and provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has 2 published articles in the BPG. 5 Issues raised: (1) I found the title was more than 18 words. The title should be no more than 18 words; (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) I found the authors did not add the PMID and DOI in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; and (4) the author should number the

	<p>references in Arabic numerals according to the citation order in the text.
