2	<p><i>Editorial Office's Comments</i></p> <p><b>Science Editor: 1</b> Scientific quality: The manuscript describes a basic study of the S100A6 and associated lncRNAs as biomarkers in the diagnosis and staging of primary biliary cholangitis. The topic is within the scope of the WJG. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The authors tried to identify novel biomarkers in the diagnosis and staging of primary biliary cholangitis by in silico, in vitro, and in vivo methods. are comprehensively searching for biomarker candidates using a reliable approach, and the results obtained were considered as novel biomarker candidates for PBC. However, some questions raised by the reviewer should be answered; and (3) Format: There are 4 tables and 9 figures. A total of 44 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, Institutional Animal Care and Use Committee Approval, The ARRIVE Guidelines, and the Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; and (3) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text. 6 Re-Review: Required. 7 Recommendation: Conditional acceptance.
