The topic is within the scope of the WJCC. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This case describes an adult patient who survived due to a ventricular septal defect and a patent ductus arteriosus that allowed some oxygenated blood to be pumped into the descending aorta. IAA should be considered in adults with refractory hypertension or unexplained congestive heart failure; and (3) Format: There are 5 figures. A total of 9 references</p>	[Y]

are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided the written informed consent and CARE Checklist-2016. Please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement; No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. Without financial support. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
