The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This manuscript deals with an interesting topic. However, the CASE SUMMARY section in the abstract needs to be modified with improved clarity. There are many grammar errors, and some</p>	[Y]

expressions in the main text need to be rephrased appropriately. The authors should include some well written references as suggested. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 15 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade C. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the written informed consent and the CARE Checklist-2016. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCC. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) I found the "Case Presentation" did not meet our requirements. Please re-write the "Case Presentation" section, according to the Guidelines and Requirements for Manuscript Revision; (3) please provide an audio core tip file where the core tip content is recorded; and (4) please provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. 6 Re-Review: Required. 7
