The topic is within the scope of the WJGO. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: This review investigated a different association between alcohol intake and gastric cancer risk between men and women. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. A total</p>	[Y]

of 38 references are cited, including 6 references published in the last 3 years. There are 4 self-citations (Ref. 5, 6, 11, 30). The topics of some self-citations are not very related to this study. 2 Language evaluation: Classification: Grade B. A language editing certificate issued by Grammarly was provided. 3 Academic norms and rules: No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an invited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJGO. 5 Issues raised: (1) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (2) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (3) Authors should always cite references that are relevant to their study. And authors should not cite their own unrelated published articles. Please check and remove any references not relevant to this study. 6 Recommendation: Conditional acceptance.
