The questions raised by the reviewers should be answered; and (3) Format: There are 4 tables and 5 figures. A total of 56 references are cited, including 4 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A and two Grades B. A language editing certificate issued by JWEDIT was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by China National Natural Science Foundation Project, Inner Mongolia Autonomous Region Talent Development Fund project. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors did not provide the approved grant application form(s).
