## Urinary Retention

Also known as: ischuria

Inability to voluntarily empty the bladder completely or partially.

### Common causes

Urinary retention is not always related to an underlying condition. It may be caused by:

- Medication side effects
- Vaginal childbirth
- Foreign body inserted into urethra

### Treatment

**Self-treatment:** Self-care steps that may be helpful in some less-serious cases:

- Fluid and diet modification- Avoid processed food, artificial sweeteners, acidic or spicy food
- Bladder retraining- Includes scheduled bathroom visits and delaying urination
- Kegel exercises- exercises to strengthen the pelvic muscles
- Limit beverages that increase urination, including caffeinated drinks like
