The questions raised by the reviewers should be answered; and (3) Format: There are 4 figures. A total of 19 references are cited, without references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B. 3 Academic norms and rules: The authors provided the CARE Checklist-2016 and informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Funding from the Beijing Municipal Administration of Hospitals' "Peaking Climbing" Talents Training Program; and the Capital's Funds for Health Improvement and Research. The topic has not previously been published in the WJCC. The corresponding author has published 1 article in the BPG. This manuscript is the resubmission of manuscript No. 56399. 5 Issues raised: (1) I found the authors did not provide the approved grant application form(s).
