images. However, this is one of the few early study investigated the feasibility of autosegmentation of the cardiac substructures in four-dimensional CT, respiratory-gated, non-contrasted imaging. The questions raised by the reviewer should be answered; and (3) Format: There are 3 figures. A total of 17 references are cited, including 8 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, The ARRIVE Guidelines, and the Institutional Review Board Approval Form. The authors should provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The topic has not previously been published in the WJCO. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (3) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (4) The "Article Highlights" section is missing. Please add the "Article Highlights" section at the end of the main text; and (5) The
