The topic is within the scope of the WJGO. (1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors found an interest manuscript on FGPD/CAs. FGPs are a common finding in endoscopy, with little</p>	[ Y]

emphasis in the literature on the risk of FGPD/CAs and a management strategy when identified. However, the data on this topic is limited. The questions raised by the reviewers should be answered; and (3) Format: There are 2 tables and 3 figures. (4) References: A total of 46 references are cited, including 5 references published in the last 3 years; (5) Self-cited references: There are no self-cited references; and (6) References recommend: The authors have the right to refuse to cite improper references recommended by peer reviewer(s), especially the references published by the peer reviewer(s) themselves.
