In this study, the authors studied the function and mechanism of oligofructose on diabetic remission in diabetic rats after sleeve gastrectomy. The animal models are good, and the research methods are reasonable. The questions raised by the reviewers should be answered; and (3) Format: There are 5 figures. A total of 47 references are cited, including 13 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B and Grade B. A language editing certificate issued by AJE was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by Science Fund for Creative Research Groups of the National Natural Science Foundation of China. The topic has not previously been published in the WJD. 5 Issues raised: (1) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (2) The authors did not provide original pictures. Please provide the original figure documents.
