The topic is within the scope of the WJG. (1) Classification: Grade A, two Grades B, and Grade C; (2) Summary of the Peer-Review Report: This is a very nice and original study. written. The results could have an impact in clinical practice regarding prognosis of pancreatic cancer or treatment strategy. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 7 figures. A total of 34 references are cited, including 14 references published in the last 3 years. There is 1 self-citation (Ref. 16). The topic of the self-citation is related to this study. 2 Language evaluation: Classification: Two Grades A, Grade B and Grade C. A language editing certificate issued by 51runse was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, the Institutional Animal Care and Use Committee Approval Form or Document, and the Institutional Review Board Approval Form. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by National Natural Science Foundation of China. The topic has not previously been published in the WJG. 5 Issues raised: (1) The "Author Contributions" section is missing. Please provide the author contributions; (2) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (3) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (4) PMID and DOI numbers are missing in the reference list.
