The topic is within the scope of the WJR. (1) Classification: Grade B; (2) Summary of the Peer-Review Report: This is a very interesting topic. It is recommended that the authors describe the incidence or risk of systemic arteriovenous thrombosis</p>	[Y]

in COVID-19 cases. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 33 references are cited, including 24 references published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade A. 3 Academic norms and rules: The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement. No academic misconduct was found in the CrossCheck detection and Bing search. 4 Supplementary comments: This is an invited manuscript. The topic has not previously been published in the WJR. The corresponding author has not published articles in the BPG. 5 Issues raised: (1) I found no "Core Tip" section. Please provide the core tip; and (2) I found the authors did not provide the original figures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Re-Review: Required. 7 Recommendation: Conditionally accepted.
