The topic is within the scope of the WJCC. (1) Classification: Grade C; (2) Summary of the Peer-Review Report: The manuscript describes an interesting case of pulmonary arterial sarcoma. While the clinical case is worth reporting because pulmonary arterial sarcoma is such a rare disease. The questions</p>	[Y]

raised by the reviewers should be answered; and (3) Format: There are 3 figures. A total of 10 references are cited, including 7 references published in the last 3 years. There are no self-citations.

2 Language evaluation: Classification: Grade C. A language editing certificate issued by FSeditor was provided. 3 Academic norms and rules: The authors provided the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. No financial support was obtained for the study. The topic has not previously been published in the WJCC. 5 Issues raised: (1) The language classification is Grade C.
