(1) Classification: Grade B and Grade C; (2) Summary of the Peer-Review Report: The authors used several method and techniques to research the correlation between MRPL35 and gastric carcinoma. gastric cancer therapy. However, some minor issues should be solved. The questions raised by the reviewers should be answered; and (3) Format: There is 1 table and 7 figures. A total of 17 references are cited, including 9 references published in the last 3 years. There are 2 self-citations. 2 Language evaluation: Classification: Grade A and Grade A. A language editing certificate issued by MedSci was provided. 3 Academic norms and rules: The authors provided the Biostatistics Review Certificate, and Institutional Review Board Approval Form. The authors need to provide the signed Conflict-of-Interest Disclosure Form and Copyright License Agreement, and the written informed consent. No academic misconduct was found in the Bing search. 4 Supplementary comments: This is an unsolicited manuscript. The study was supported by 1 grant. The topic has not previously been published in the WJG. 5 Issues raised: (1) The authors need to provide the structural abstract; (2) The "Author Contributions" section is missing. Please provide the author contributions; (3) The authors did not provide the approved grant application form(s). Please upload the approved grant application form(s) or funding agency copy of any approval document(s); (4) The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor; (5) PMID and DOI numbers are missing in the reference list. Please provide the PubMed numbers

	<p>and DOI citation numbers to the reference list and list all authors of the references. Please revise throughout; (6) The “Article Highlights” section is missing. Please add the “Article Highlights” section at the end of the main text; and (7) Authors should always cite references that are relevant to their study. Please check and remove any references that not relevant to this study. Authors should not cite their own unrelated published articles.
