CT on the first day after surgery should be more carefully analyzed for signs of bleeding; and supplement the literature on the causes of secondary delayed gastric perforation. The authors should consider what enlightenment does this patient bring to us. The questions raised by the reviewers should be answered; and (3) Format: There are 6 figures. A total of 14 references are cited, including 1 reference published in the last 3 years. There are no self-citations. 2 Language evaluation: Classification: Grade B, Grade B, and Grade B. A language editing certificate issued by Editage was provided. 3 Academic norms and rules: The authors provided Signed Informed Consent Form(s). Please download and complete the 'CARE Checklist – 2016: Information for writing a case report' to ensure that the document meets the journal's requirements.
