Summary of the peer-review report: This case report focused on a patient with locally advanced HER2-positive gastric cancer invading the pancreatic head, which was successfully treated with PD after neoadjuvant chemotherapy and anti-HER2 therapy. This manuscript is interesting, and is of scientific interest. Here are some questions or advice. To show pancreatic invasion by cancer cells clearly, a pathological figure with high magnification should also be provided. What is the safety of trastuzumab in the treatment of gastric cancer, especially in combination with other anti-tumor drugs? How to avoid side effects in combination therapy? The questions raised by the reviewers should be answered. (3) Format: 1 table and 7 figures. 22 references were cited, including 7 references published in the last 3 years. No self-citation. 2 Language evaluation: B and B. Language editing certificate was provided by Textcheck. 3 Academic norms and rules: The informed consent statement and CARE Checklist were uploaded. The authors are required to sign the conflict-of-interest disclosure form and copyright license agreement. No academic misconduct was found in the Bing search. 4 Supplementary comments: (1) Unsolicited manuscript. (2) Without financial support. (3) Corresponding author has not published articles in the WJG. 5 Issues raised: The authors did not provide original pictures. Please provide the original figure documents. Please prepare and arrange the figures using PowerPoint to ensure that all graphs or arrows or text portions can be reprocessed by the editor. 6 Recommendation: Conditional acceptance.
